**STIPULATION RE DISMISSAL AS TO  
RELIEF DEFENDANT TINA M.  
PLACOURAKIS**


1 Plaintiff Securities and Exchange Commission (“Commission”) and relief  
 2 defendant Tina M. Placourakis (“Placourakis”) have agreed to stipulate to the  
 3 dismissal, pursuant to Fed. R. Civ. P. 41(a)(1)(A)(ii), of the Commission’s claim  
 4 against relief defendant Placourakis, without cost or fees to either party.  
 5 Accordingly, relief defendant Placourakis waives any rights under the Equal  
 6 Access to Justice Act, the Small Business Regulatory Enforcement Fairness Act of  
 7 1996, or any other provision of law, to seek from the United States, or any agency  
 8 or any official of the United States, reimbursement of attorney’s fees or other fees,  
 9 expenses, or costs. Solely for these purposes, Placourakis agrees that she is not the  
 10 prevailing party in this action since the parties have reached an agreement to  
 11 dismissal of the Commission’s claim.

12 IT IS HEREBY STIPULATED AND AGREED that the Commission  
 13 dismisses with prejudice its claim against relief defendant Tina M. Placourakis.

14 IT IS FURTHER STIPULATED AND AGREED that Placourakis may be  
 15 released from any obligations arising from this Court’s March 10, 2009  
 16 Preliminary Injunction in this action, and the asset freeze provisions of that  
 17 Preliminary Injunction shall no longer apply to assets held in the name of, or for  
 18 the benefit of, Placourakis.
